The Company advises that, following this purchase, the Company's issued share capital remains at 25,567,522. The total number of shares with voting rights is now 19,249,775 This figure represents the total voting rights in the Company and may be used by shareholders as the denominator for the calculations by which they can determine if they are required to notify their interest in, or a change to their interest in, the Company in compliance with Thalassa's Articles of Association.
